Sana Kisan Bikas Laghubitta Bittiya Sanstha Ltd (SKBBL) have signed partnership agreement with Sakchyam A2F program for implementation of Digitization of SFACs and Expansion of Assess to Finance in Karnali Province (DSFACs & A2F) program. SKBBL intends to apply part of the grant to cover eligible payments under the contract for the procurement of Tablet Sets (Combination Tablet, Printer, and Biometric scanner in one set) -700 nos to cover eligible payments under the Contract for the Supply and Delivery of Tablet Sets. Bidding is open to all eligible Bidders.
2. The SKBBL invites sealed bids from eligible bidders for the procurement of Tablet Sets under National competitive bidding procedures specified in Public Procurement Act and Regulations and Procurement rules of SKBBL.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of SKBBL, Subidhanagar Kathmandu, Nepal.
4. A complete set of Bidding Documents in English may be purchased from the office of SKBBL or from the office of Agricultural Development Bank Regional Office Battishputali Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 5,000.00 on or before September 07, 2019 during office hours. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 2,500.00. However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent.
5. A Pre-Bid Meeting shall be held at the office given below at 13:00 hours, on August 29, 2019.
6. Sealed Bids must be submitted to the office given below on or before 12:00 hours on September 08, 2019. Bids received after this deadline shall not be accepted.
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on September 08, 2019 at the office of Sana Kisan Bikas Laghubitta Bittiya Sanstha Ltd (SKBBL) Subidhanagar Kathmandu, Nepal.
8. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security amounting to a minimum of NRs. 800,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. January 05, 2020)
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
